#### 2008 Full of Berkeley-Related Activities

Even though it was not the 300<sup>th</sup> anniversary of any major event in George Berkeley's life, 2008 turned out to be quite a year for celebrating his thought. In March the Edinburgh Philosophy Society hosted a symposium (co-sponsored by the IBS) on Berkeley's ideas and idealism; and in April and December, our Philosophy Associations Coordinator Margaret Atherton arranged for sessions on Berkeley at the American Philosophical Association meetings in Chicago and Philadelphia. For his graduate seminar in the fall, **Sébastien Charles** (Sherbrooke, Québec) invited Frédéric Brahami, Roselyne Dégremont, Luc Peterschmitt, Stephen Daniel, George Caffentzis, Roomet Jakapi, and Bertil Belfrage to speak about Berkeley's Alciphron. And in October James Van Cleve was part of Brown University's kick-off of its lecture series to mark 2009 as the 300<sup>th</sup> anniversary of Berkeley's New Theory of Vision.

The highlight of the year, though, was a three-day conference in June at the Redwood Library and Athenæum in Newport, Rhode Island. Organized by Steve Daniel, Maureen Lapan, Nancy Kendrick,

Nancy Bredbeck, Joanne Dunlap, and Vince Arnold, the event brought together 56 scholars and participants from North America and Europe to share ideas about Berkeley's work. Special treats included a talk by Sean Berkeley (an Aussie descendant of the "good bishop") on a John Smibert portrait of the young Berkeley owned by his family; a demonstration by Cynthia Grund (U Southern Denmark) on visiting Berkeley's home in Newport (Whitehall) online in "Second Life"; a walking tour of Newport and Trinity Church (where Berkeley preached) guided by John Hattendorf (Naval War College); and a bus tour of Berkeley-related sites near Newport that ended with a dinner at Whitehall.

In appreciation for the Redwood's hospitality, Steve Daniel and Maureen Lapan created a three-panel brochure ("George Berkeley in Newport") for the Library to give to visitors. The brochure, which describes points of interest in the area, is also available at Whitehall and at the Old Narragansett Church and Smith's Castle in Wickford.

### 2008 Business Meeting Focuses on Finances

At last January's annual meeting, IBS Secretary-Treasurer Nancy Kendrick announced that in 2007 the Society's income rose significantly. Payment of dues nearly doubled, Whitehall library contributions more than doubled, and contributions to a new fund to support research increased our ability to support publishing and conference work. The number of members contributing to the Whitehall library rose from 27 in 2006 to 77 in 2007; and 20 members contributed to the new research fund. The increases, Kendrick noted, are linked to two factors: email and surface mail reminders by Membership Secretary Genevieve Migely and the introduction of online dues renewal and donation payments with PayPal.

In 2007 the Society received \$1487 in dues, \$483 in Whitehall library donations, and \$235 in research contributions. The sale of cards and miscellaneous items added another \$35, so our overall income was \$2240. The expenses for the year (\$1539) included a \$500 subvention for the publication of Reexamining Berkeley's Philosophy, edited by Stephen Daniel (Toronto University Press), \$400 for a conference on Berkeley in Gaeta, Italy, a \$200 donation to the Colonial Dames of America to support their efforts at Whitehall, \$321.78 for a Verizon wireless internet hookup at Whitehall for scholars in residence, \$43.73 mailing costs, and \$53.49 for a file cabinet. Thanks to the support of the philosophy departments at Texas A&M University and Cornell College (Iowa), costs for mailing and copying have been cut substantially. At the end of 2007 the IBS had \$7273.65 in its

accounts: \$1992.63 committed to the Study Center Fund, \$535 committed to the Staley Research Fund, and \$4746.02 in uncommitted funds.

In the past, members who had not paid their dues for several years were kept on the membership list. Now only those who have paid dues in the last three years are retained. Initially, this change in record keeping resulted in a drop in membership from 150 to about 100. But the Society now has 118 active members, with another 20 arrears in dues payments.

Half of our members are involved in teaching and research (mostly in philosophy), and half are either retired academics or non-academicians interested in Berkeley (especially his time in Rhode Island). Two-thirds live in the U.S.; the rest live in England, Canada, France, Ireland, Italy, Denmark, Germany, Finland, México, Sweden, Switzerland, Scotland, Slovenia, Hungary, Poland, Lithuania, Estonia, Japan, Australia, and Russia.

#### Julia Berkeley Portrait

James Harmer Berkeley Colquhoun Paterson of Cardiff, UK, has written to ask if anyone in the IBS might help in identifying this young lady. He reports that the painting has been in his family for many years and has always been described as being of Bishop Berkeley's daughter, Julia. He writes: "Apparently on my mother's side (who came from Ireland) we have some connection to Bishop Berkeley. My grandfather was born in Passage West, County Cork, and bore the Christian names Edward Berkeley, as did his son Harmer Berkeley, my mother's brother. . . . So far while searching my family in Ireland I have not found what our connection might be. I have got Atkins (my grandfather's name), Cotters, Bond, and Meara. What I would like to know is this: do you know of any other portraits of Julia Berkeley?"
