Conference and Event Highlights 2015-2016

Scholars from around the world met at the Hebrew University of Jerusalem in January 2016 for a fourday conference on Berkeley's philosophy. (Click <u>here</u> for the complete program.) Yaron Wolf, an Oxford Ph.D. student, received a Young Scholars Travel Award from the Society and presented "*Alciphron* and Berkeley's Theory of Sense Perception" at the conference. More than two dozen scholars participated in the meeting, which was organized by Meir Buzaglo (Hebrew U) and Bertil Belfrage (Lund).

Also in January, the IBS held a session at the Eastern Division of the American Philosophical Association in Washington, DC. Melissa Frankel (Carlton, Canada) presented "Descartes and Berkeley on Sensory Perception" and Nathan Sheff (Connecticut) presented "Berkeley's Dilemma for Temporal Absolutists." IBS Past-President Steve Daniel chaired the sessions.

January also saw a celebration marking the 287th anniversary of Berkeley's arrival in the American colonies. Art historian R. Tripp Evans (Wheaton College, MA) gave a slide-show presentation and lecture on "Berkeley's Influence on Art and Architecture in America" at the White Horse Tavern in Newport, Rhode Island. Forty guests attended

the event, including IBS notables Maureen Lapan (founding member) and Louis Alfonso (Past-Past-Past President), as well as Benedict Lica, Executive Director of the <u>Redwood Library</u> and Norah Diedrich, Executive Director of the <u>Newport Art Museum</u>. The evening was cosponsored by the IBS and the Whitehall Committee of the Colonial Dames of America.

Samuel Rickless (UCSD) was the inaugural guest in December 2015 for a new video series on recent work in the history of early modern philosophy hosted by Benjamin Hill at the University of Western Ontario. Rickless discussed his book Berkeley's Argument for Idealism (Oxford, 2013). The series is a cross between an "author meets critics" session and a journalistic interview and provides a virtual Master class on a given text. Questions for the author are collected from Western researchers and students, from published book reviews, and from invited experts from around the world. The queries are shared with the author and presented in an on-line videoconference that is recorded and posted to Western's website and youtube channel. The aim is to encourage authors to expand, clarify, explain, and defend their texts in response to critical questioning. Whitehall News

The IBS Study Center at Whitehall has received a gift of over 70 books, pamphlets, articles, and ephemera from the libraries of Maureen Lapan and the late Raymond Houghton. Lapan and Houghton, along with three other Rhode Island historians, founded the International Berkeley Society in 1975;

Houghton was the Society's first president. The donation includes a of Berkeley's set Collected Works edited by Fraser, a set of the Works edited bv Luce and Jessop, edited several



volumes of commentary on Berkeley's philosophy, and a rare copy of Thomas Prior's *Authentick Narrative of the Success of Tar-Water*, published in 1746 (Dublin printed, London re-printed). 2015 Financial Report

IBS Secretary-Treasurer Keota Fields reports that dues payments for 2015 were \$2025, while expenditures for the year were only \$352. The Society did not provide financial support to any conferences during the 2015 calendar year, and it did not fund any young scholars. The bulk of 2015's expenses (\$330) were connected with cosponsoring a dinner and lecture on "Berkeley's Influence on Art and Architecture in America" at the start of 2016. The remaining \$22 was a registration fee paid annually to the Rhode Island Secretary of State.

In Memoriam



Paul J. Olscamp died in Coeur d'Alene, Idaho in October 2014. He was the author of *The Moral Philosophy of George Berkeley*

Thomas with Lennon. and. the editor/translator of Malebranche's The Search After Truth. He served as president of Bowling Green State University from 1982 until his retirement in 1995. In retirement, he was an interim president of the University of Dakota and of Mayville South State University in North Dakota. Born in Montreal, Aug. 29, 1937, Olscamp earned bachelor's and master's degrees from the University of Western Ontario and a Ph.D. from the University of Rochester. He began his academic career in the philosophy department of the Ohio State University and went on to hold administrative posts at a number of American universities. He is survived by his wife, Ruth and children, Rebecca and Adam.

Nancy Preston Bredbeck, of Newport, Rhode Island, died April 5, 2016. A tireless champion of Whitehall, Nancy served as



President of the Rhode Island chapter of the Colonial Dames and organized scores of gatherings at Berkeley's eighteenth-century residence. She worked closely with the IBS in planning Newport conferences and in recruiting resident scholars for Whitehall. Born on December 25, 1940 in Detroit, MI, Nancy earned a bachelor's degree from Occidental College and masters' degrees from the University of California at Berkeley and Wayne State University. She was an artist and a teacher at the Newport Art Museum. Nancy was the wife of the late Captain William J. Bredbeck (U.S.N., Ret.) and is survived by her children, William and Katherine, and several grandchildren.
